In 2016 Sofindev celebrates its 25th anniversary. Sofindev was created in 1991 by Sofina and Colruyt. Since the early 1990s Sofindev is one of Belgium's most important investment funds providing private equity to Belgian small and medium sized enterprises. In May 2015, a new Sofindev fund, Sofindev IV was created by the same management team that realized and managed the investments of Sofindev III. Sofindev IV is a fund with aggregate commitments of 107 MEUR, dedicated to invest private equity in small and medium-sized Belgian companies with significant growth potential.

The investors behind Sofindev IV are, next to the historical shareholders of Sofindev (Sofina, the Colruyt family and Colruyt Group), a group of Belgian investors, including multiple entrepreneurs who were partners of Sofindev portfolio companies in the past.

In May 2015, Sofindev IV has realized a first investment, in Fedrus Invest Groep, the Belgian market leader in wholesale and distribution of building specialties and roof building materials.

In March 2016, Sofindev IV has closed its fundraising with a fund size of 107 MEUR, above its initial target of 80 to 100 MEUR.

Other investments of Sofindev are women's clothing retailers Cassis and Paprika, manufacturer of cooker hoods Novy, supplier of furniture, boards and technology products for learning environments i3 Group and Syx Automations Group, supplier of software and automation solutions to the leisure and visitor attraction sector.
